We are holding a few GDPR Briefings for volunteers to explain that process and what we expect of them.

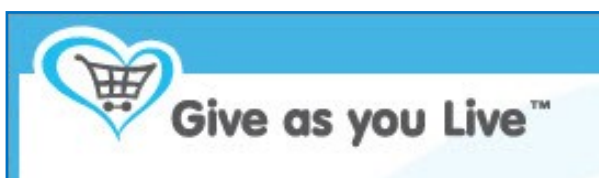
