We have some very sad news to share. Our Caseworker, Christine de Cintra (Nee Willmington) passed away on 10th August following a long battle with cancer. She will be greatly missed.

Christine was a member of 'Class of 2012' for new Community Mediators, alongside the likes of Elspeth, Suzanne, Hazel and others who have since left the service.

In November 2016 Christine joined our paid staff to help out in the office with casework, on a part-time basis. She stepped aside whilst undergoing her initial treatment.

Colleagues were privileged to be asked by Christine to witness her marriage to her long term partner, David, in a ceremony at Park House, in August 2019. Afterwards we had a celebratory drink at the Black Jug pub, just down the road.

In November 2021, having been diagnosed with secondary cancer, Christine was informed that it was terminal. She had kept matters private since then, but with colleagues keeping in touch with her.

Christine ended her days in the comfort of Valerie Manor Nursing Home in Upper Beeding. Her husband David was by her side when she passed.

Prior to mediation, Christine's previous career included HR with Chevron International Oil Co Ltd and she was also a Personnel Officer before becoming a Freelance ESOL/Basic Skills Tutor and Career Consultant/Coach.

Christine's funeral will be held at 1 pm on Tuesday 30th August at Worthing Crematorium. Up to 10 representatives from WSMS are welcome to attend, so if you would like to join staff members, do let the office know and we will pass final numbers on to the family. We are happy to pass on any messages to Christine's family.

GDPR — we remind all referrers of the need to get permission from parties to disclose their personal information to us before passing a referral on. We had a recent case, regarding a referral from a Housing Association, which led to a 'Subject Access Request' (SAR) being sent to us as the client was not happy about the data breach. The originator of the referral believed that they hadn't done anything wrong.

An SAR gives individuals the right to obtain a copy of their personal data, as well as other supplementary information. It helps individuals to understand how and why you are using their data, and check that you are doing it lawfully.

WSMS were not liable in this situation as we received the information in good faith and had legitimate interest in contacting the client. The SAR was duly completed and returned to the originator and the client's data deleted from our system.

Office Help — we are pleased to announce that we have recently attracted two new volunteers to help us out with Admin tasks in the office. Pamela & Sue will cover different days of the week and support Nick and the Caseworkers with various activities. Both live locally to our offices in Horsham.

Raffle — as mentioned in last month's newsletter, our Service Co-ordinator is currently attempting to organise a Grand Raffle, prior to his retirement. Conflict Coaching Training - the dates are now set for this. Kathy Whitestone from Brighton & Hove Independent Mediation Service (BHIMS) will be providing the training for us, via Video Conferencing, on Friday 2nd and 9th September. The timing has changed very slightly to 10.15am to 1.15pm each day. Luckily we have attracted good number who are able to attend on those dates.


A grant from the Gatwick Area Community Trust has helped us pay for this training. Next up will be Mental Health First Aid training.

Ukrainian refugee project — thanks to some recent funding from West Sussex County Council, we have agreed to help out with conflicts between West Sussex based hosts and guests from Ukraine. Nick, our Co-ordinator hopes to arrange an information session on Zoom, one evening in the coming



weeks. He and his partner, Elayne will be able share their experiences as hosts and through contact with a wider community of hosts and guests. Much has been learned from their experience. If there are any mediators who are also acting as hosts, please do get in touch with Nick. If we do take on referrals we will have access to interpreters. Hopefully a number of our mediators will be happy to take on this new challenge. As usual with mediation, it is all about aiding communication and understanding. Not all relationships are going to work, but if we can help keep placements going it will ease the pressure on rehousing families and the stress and upset which that creates.

Funding — we are in talks with the Sussex Police & Crime Commissioner's Office, together with our Sussex Mediation Alliance partners, regarding a 'Safer Streets 4' project, which revolves around ASB and will provide us with additional funding. This is a Government funded project and



in Sussex will involve a large number of interested parties. The project runs for 18 months and targets identified Antisocial Behaviour hotspots, which in our area includes, Chichester South, Northgate, and Central ward (Worthing)
