## Reminder


AGM — our 21st Annual General Meeting is going ahead on Thursday 29th September at the Park Barn, North Street, Horsham, RH12 1RJ.

#### **Annual Report**

Our report for the year 2021-22 will be released to coincide with our AGM. It will be posted on our website where it can be viewed or downloaded alongside all past editions. It follows the format of the past few years and includes our externally examined accounts. We are grateful, once again, to Sushma Clark of 'Your Accounts Team' for carrying out that task on a *pro bono* basis.

Once the accounts are formally approved at our AGM, they will be submitted to the Charity Commission.

## Funding
